Part One

Introduction

The Freedom of Information Act 2000 promotes openness of information across the public sector and aims to enhance accountability. All public authorities are required to adopt a publication scheme in order to take a proactive approach to making information publicly available.

A publication scheme is a document which outlines the classes/type of information that the establishment is making a formal commitment to publish both now and in the future.

The Guildhall School of Music & Drama has based its publication scheme on the 'model' scheme for the higher education sector but as the School is owned by the City of London (CoL), which has its own publication scheme, it has adopted a scaled down version specific to its higher education activities.
